## Expression of Interest (Eol) for Empanelling Firms for Design & Layout

### 1. Introduction

1.1. National Health Systems Resource Centre (NHSRC) invites Expression of Interest (EoI) for empanelling firms for Design & layout of NHSRC Publications, Books, Brochures, posters etc having experience in the services for the last three years to any State/Central Govt organization or a large public sector undertaking or reputed private organization in Delhi.

1.2. The Scope and deliverables shall be determined, monitored, coordinated and governed directly by NHSRC.

1.3. The National Health Systems Resource Centre (NHSRC) is created under the National Rural Health Mission (NRHM), Ministry of Health & Family Welfare, Government of India (MoH&FW), to act as the nodal agency for Technical Assistance (TA) to central and state governments for effectively implementing NRHM, with specific focus on systems strengthening and capacity development. ### 2. Scope of Work

2.1. The scope of work includes but is not limited to the following tasks:-Design and Layout of Publications and collaterals including health related books, brochures, posters etc. and as required by NHSRC from time to time.

#### 3. **Qualification Criteria**

3.1 Interested Design & Layout Firms must have been in operation for a minimum period of 3 years in designing of books, reports, brochures, posters, folders, other collateral material, etc.

3.2 Profile and Track Record of the agency including previous work handled, major clients, empanelment with other Ministries, if any and list of technical persons available. To be submitted on the letter head of the company duly signed and stamped.

3.3 Copies of Publications and Collaterals printed in the last two years.

3.4 The firm should have a valid service tax registration number.

3.5 The firm must have an office in Delhi.

3.6 The firm should have in-house, state of art facilities for designing & layout facilities.

3.7 The firm should be able to provide a dedicated team for timely production and supply of the designed material and collaterals tendered for.

3.8 Illustrator available or in-house or easily sourced-in would be desirable.

## 4. **Evaluation Process**

4.1 There shall be a short-listing done based on scores given to the qualification criteria. Those who are shortlisted will be invited for a discussion and presentation preferably and these too would be scored.

4.2 Proposals submitted against Eol should provide straightforward, concise information that satisfies the requirements of this Eol. Emphasis should be placed on completeness, clarity of content and conformance with given instructions and requirements of this Eol.

4.3 The interested firms/ companies must show that they have the capacity to complete the work in time.

4.4 The interest firm must share their past experience and proven track record of conducting and executing similar assignments.

4.5 The proposal should indicate that the firm has knowledge and understanding of the scope of work to be performed.

## 5. Validity of Empanelment

The empanelment shall be valid for a period of one year from the date of empanelment. The initial period of one year can be further extended subject to satisfactory services at the sole discretion of the office of the client.

## 6. Submission Details

6.1 Interested agencies are invited to submit their EoI which should include:

6.1.1 Details of the Design & Layout firm's certified copies of all the necessary documents to be enclosed **(***Refer Annexure-1***)** 

6.1.2 Financial capability statements (last three years audited annual financial statements of the Firm) *(Refer Annexure-2)* 

6.1.3 Past experience of the firm (with relevant document proof of each credential stated, in form of work order/ letter of award/ completion certificate) (*Refer Annexure-3*)

6.1.4 Project undertaking (as stated in Eligibility Criteria (*Refer Annexure-4*)

6.1.5 A minimum of three current references from clients (at least one from Govt. organizations) for whom similar work has been provided within the last three years. *(Refer Annexure-5)* 

6.1.6 Any other information relevant to the project (*Refer Annexure-6*)

6.2 Interested Firms must sign each page of the EoI to be submitted to NHSRC and provide all the required information on separate sheets but strictly as per the Annexure listed. The EoI should be submitted latest by 1300 hours on 09 September 2013 to the address mentioned below.
