Dear *Shri*,

You are aware that transforming Sub Health Centres (SHCs) to Health and Wellness Centres (HWCs) has been announced in the Union Budget FY 2017-18. HWCs are envisaged to provide a comprehensive set of 12 services:

- IMPORTANT*
- I. Comprehensive Maternal Health care services to be provided in those sites equipped to service as "delivery point".
  - II. Comprehensive neonatal and infant health care services
  - III. Comprehensive childhood and adolescent health care services
  - IV. Comprehensive contraceptive services
  - V. Comprehensive reproductive health services
  - VI. Comprehensive management of communicable diseases
  - VII. Screening and Comprehensive management of non communicable diseases
  - VIII. Basic ophthalmic care services
  - IX. Basic ENT care service
  - X. Screening and basic management of mental health ailments
  - XI. Basic dental health care
  - XII. Basic geriatric health care services

Transformation of SHCs to HWCs is envisaged to be operationalised through a team led by Mid Level Provider (Nurses/Ayurveda) after undergoing suitable training in public health and primary care or B. Sc. Community Health.

2. An indicative costing of the HWCs has been prepared and enclosed herewith.
3. May I request you to kindly budget the proposals for HWCs in the PIPs accordingly. May I also request you to ensure that such support is not duplicated and is based on actual gap analysis in existing SHCs.
