Advisor – Healthcare Technologies

Role and Responsibilities:

- Lead the work of technology division and develop and implement work plan in consultation with MOHFW, State Governments & other state holders.
- Support identification-assessment and uptake of health technology innovations as per NHSRC process & procedures.
- Supervising market research surveys on health products when requested by Ministry of Health & Family Welfare and other related Ministries.
- Formulating and supporting implementation of technology intensive health programs such as Free Diagnostics & District Dialysis Program.
